There will be 20 seasonal sites available from the attached list. Those marked NA are not available. Five (5) alternate sites will be offered in Loop 1, sites 75-93.

Rank your preference order for campsites with "1" being your most preferred site and "20" your least desired site. Do not put a preference number next to a site which is unacceptable to you. It is your responsibility to know if your camping unit will fit on any site you rank. At the drawing the first 20 sites selected will be the seasonal sites for the year. You should rank order at least 20 sites since that is the number of sites that will be selected. The five (5) alternate seasonal sites will be offered in order names are drawn after the first 20 are selected.

I acknowledge that I have read and understand the attached seasonal and general campground regulations and will fully comply with them if I am awarded a seasonal site. Repeated violations of these regulations will result in cancellation of my agreement and I will vacate the campsite within ten (10) days of the cancellation without refund of any fees.

2020 Fisherman's Point Campground Seasonal Sites Drawing

1. Comply with all Campground regulations as stated on the Campground Rules. Violation of these rules or any of the rules below will be cause for cancellation of this agreement.
2. The total payment for the site will be \$2,300 with a deposit of \$1,000 (lakeshore) or \$2,000 with a deposit of \$1,000 (non-lakeshore) due within 10 days of the drawing and the balance due by April 17, 2020. Refunds will only be made as a result of emergencies in which case 75% will be refunded if canceled by June 1, 50% by July 1, and no refunds after July 1.
3. The sites will be available on April 17, 2020 until October 31, 2020 at which time all personal property must be removed and the site left in a clean condition. Tenants must pay \$12.50/day non-seasonal rate for any stay past or prior to these dates. The availability of water and rest rooms is weather dependent. If this is a concern for you, please call the Campground Office on May 1 or after before you move in (225-3337). The campground office and restroom/showers will close on September 24th. The year-around restroom facility located near the office will be closed after October 31st.
4. Seasonal campers will do their own grass cutting and campsite cleanup. This must be done on a regular basis.
5. All camping units except tents must be wheeled vehicles. Seasonal campers are not permitted to make any site improvements including moving in of storage units, docks, landscaping, etc. A daily fee will be charged for any additional camping unit on a seasonal site with the exception of one additional small tent.
6. Only one form may be submitted per household/camping unit.
7. A drawing will be held at 2:00 p.m. on Friday, September 27, 2019. If interested, submit this form to the City of Hoyt Lakes, 206 Kennedy Memorial Drive, Hoyt Lakes MN 55750.
8. An adult from the immediate family household must be present overnight when the campsite is in use. When an adult from the immediate family household is not present overnight then no one else may utilize the site unless the seasonal site holder provides written permission to the campground manager. The regular daily campsite fee will be charged to anyone else utilizing the site in the absence of an adult from the immediate family household.
