Tom Erickson – 313 Andover: asked the council to raise their hands if they want and support Mudder's Market. He stated currently only 10% of city residents support Mudder's Market and their projections were 40% support is needed. Mudder's Market is really struggling, and he doesn't know why the community isn't supporting the store. Mudder's has done a lot to support the community. Their meat cutter is 2nd to none, and they've cleaned out the store. They intend to make more improvements like the flooring. They also plan to clean and update the east end of the store and see if it is viable. The community needs to support them. They would like to bring in a deli and make sausage. He would like the council to

reach out and support them and stated the council hasn't welcomed them as new business owners. He would like to thank the board and the city for basketball court getting done.
