City Administrator Lammi – There are still scheduling issues with the ER Joint Water Board and finding a time that works for all parties. Congratulations to everyone who won their elections. With additional mandates from the State, we will shoulder a cost of \$1,371.65 in Clerk's Office over-time for elections, not including the costs that are hard to identify, such as lost productivity. Discussed the East Range Times bill. Advised we received the \$250,000 grant from the Department of Iron Range Resources and Rehabilitation for the Wellness and Recreation Center.

Public Works Utilities Director Berndt – Discussed status of Lead Service Line Inventory. There are no lead service lines in town. The State will require ongoing inspections. They have obtained a reduction in manganese at the Water Treatment Facility.
