2024 Fisherman's Point Campground Seasonal Sites Drawing

1. Comply with all Campground regulations as stated on the Campground Rules. Violation of these rules or any of the rules below will be cause for cancellation of this agreement. If you are removed for any reason, no refunds will be issued.
2. The total payment for the site will be \$3,000 with a deposit of \$1,500 (lakeshore) or \$2,500 with a deposit of \$1,250 (non-lakeshore) due by 4:00pm on Monday, October 7, 2024. The second half payment is due by 4:00pm on Thursday, April 17, 2025. Partial payments will not be accepted; only two payments totaling 50% of total cost will be accepted for seasonal sites. Refunds will only be considered in extreme circumstances at the discretion of the City Administrator.
3. The sites will be available on April 18, 2025 until October 31, 2025 at which time all personal property must be removed and the site left in a clean condition. In the months of April, September, and October the availability of water, docks, rest rooms, and other amenities is weather dependent and subject to closure/removal at any time.
4. Seasonal campers will do their own grass cutting and campsite cleanup. This must be done on a regular basis.
5. A \$100.00 pet fee for each pet is due prior to check-in. If complaints are received and it is discovered the camper has a pet which was not disclosed, the seasonal agreement will be considered cancelled.
6. The seasonal site fee includes electricity fees for the appliances in your camper. If you wish to have additional freezers or refrigerators plugged in outside, there will be an extra \$100.00 fee per appliance due upon check-in.
7. All camping units except tents must be wheeled vehicles. Seasonal campers are not permitted to make any site improvements including moving in of storage units, docks, landscaping, etc. A seasonal camper is permitted to have one camping tent and one screen house at no additional cost. Two campers are not permissible under any circumstances.
8. Any seasonal camper permitting another person, who is not a nuclear family member, to use their seasonal site will forfeit their seasonal site and the seasonal agreement will be considered cancelled.
9. Each application for 2025 seasonal camping will have a fee of \$20.00, due by 11:30 am on Friday, September 20, 2024. Late applications or payment will not be accepted. 10. A drawing will be held at 10:00 a.m. on Thursday, September 26, 2024 at Hoyt Lakes Arena in the multi-purpose room. Names for the 30 sites plus 20 alternates will be drawn. **All seasonal site applications and payments must be submitted to the Hoyt Lakes City Clerk's Office, 206 Kennedy Memorial Drive, Hoyt Lakes MN 55750 by 11:30am on Friday, September 20, 2024 to be considered for the drawing.**
